



## Horseback Riding Liability Waiver

This agreement entered into this \_\_\_\_\_ day of \_\_\_\_\_ 20\_\_\_\_, as a precondition of riding horses upon trails operated by Christ the King Spiritual Life Center, hereinafter referred to as CtK, is for the purpose of stating the rules, responsibilities, and **dangers** of horseback riding; and further, inasmuch as **horseback riding is a dangerous sport**, holding harmless CtK, its employees, volunteers, indemnifying companies and their agents and underwriters, and anyone over whose land the trails may be ridden, from any legal action or damages that may arise as a result of rider, minor children and/or animals being upon aforesaid trails, or roads adjacent thereto; and patron further agrees to abide by all rules and conditions of CtK and agrees to follow all verbal instructions of CtK, its employees, and volunteers.

### **WE REQUIRE THAT ALL RIDERS WEAR A HELMET AND ALL CHILDREN (UNDER AGE 18) MUST HAVE A PARENT/LEGAL GUARDIAN'S SIGNATURE.**

#### **Rules**

1. Each rider takes full responsibility for his/her safety, and that of any minor children in his/her care, while riding on trails operated by CtK and will not hold CtK, its employees, volunteers, indemnifying companies and their agents and underwriters, and any one over whose land the trails may be ridden, responsible for any harm or injury incurred while upon said trails, access to trails or roadways adjacent thereto.
2. CtK **DOES NOT** guarantee the condition of any trails or property ridden upon.
3. Each person listed above agrees to take full responsible care of all horses by following instructions, and to obey ALL posted and verbal rules given. For safety reasons, all riders must stay on marked trails.
4. Each rider agrees to explain all rules to minor children in his/her care and/or custody and agrees to take full responsibility for said minor children's actions.
5. There will be absolutely **NO FIREARMS, DRUGS, ALCOHOL OR SMOKING** allowed on the trails.
6. All persons riding upon the aforesaid trails shall report any hazards or injury of any type to CtK immediately upon returning from any riding session.
7. This Release/Waiver of Liability shall be binding upon the heirs, next of kin, executors, administrators and personal representatives of the undersigned.

I have read and understand the above agreements and have filled out the required information to the best of my knowledge, and I agree to abide by all the rules and further agree to hold harmless CtK, its employees, volunteers, indemnifying companies and their agents and underwriters, and all parties over which the trails operated by CtK travel, for any damages or harm which may arise as a result of me, my children and/or animals using the facilities operated by CtK. Should any part of this contract be found to be invalid, it shall not affect any provisions in the contract. In the event of a disabling accident, I hereby specifically authorize CtK and employees thereof, to summon any and all aid it/they, at their sole discretion, deem(s) necessary for me and/or my children's immediate care, and agree to hold CtK harmless for any costs related thereto.
